

# Simple Guide: Key Updates in Section 182 Guidance (2025 Edition)

This guide summarises the official Section 182 Guidance (Revised November 2025). For full legal detail, refer to the GOV.UK publication

## 1. Stronger Powers for Summary Reviews

The 2025 update reinforces how **fast-track reviews** work when the police believe a premises is linked to **serious crime or serious disorder**.

## **Key points:**

- Police can trigger a review quickly with a Superintendent's certificate.
- Licensing authorities must consider interim steps within 48 hours, including:
  - extra licence conditions
  - removing the DPS
  - suspending alcohol sales
  - o full licence suspension
- Interim steps can take effect immediately.
- · Licensing sub-committees can meet by phone / remotely to act quickly.

#### What this means for venues:

If serious incidents happen (weapons, drugs, violence), authorities can act extremely fast and impose temporary restrictions before a hearing.

# What's different?

Previous versions explained summary reviews briefly.

The 2025 revision adds procedural detail, timelines, and stricter expectations for urgent action.

## 2. Tougher Approach to Crime at Licensed Premises

The guidance makes it clear that licensing authorities should take **firm action** where crime is linked to premises.

#### New emphasis:

- Reviews may arise from crime not directly linked to alcohol sales, such as drugs, money laundering, stolen goods, firearms or exploitation.
- Councils should not hesitate to **revoke licences** if problems continue.
- Removal of a DPS may not be enough if the root issue is company policy or culture.

#### What's different?



The earlier version focused mainly on alcohol-related crime.

The 2025 update broadens the scope to any serious criminality connected to the premises.

## 3. Clarified Rules on Regulated Entertainment

Large updates appear in Chapter 16 — important for pubs, bars, clubs and events.

#### **Live & Recorded Music**

- No licence needed 08:00–23:00 (conditions apply).
- Conditions relating to music are suspended 08:00–23:00 where alcohol is authorised and audience limits are met.
- Licensing authorities can still **impose or reinstate** conditions if problems arise (noise, disorder).

## Other entertainment updates include:

- Travelling circuses: clearer exemption rules.
- Indoor sport only licensable before 08:00 or after 23:00, or over 1000 spectators.
- Recorded music remains licensable outside permitted times or with large audiences.

#### What's different?

This section has been reorganised and expanded to reduce confusion—older versions were scattered and unclear.

## 4. Early Morning Alcohol Restriction Orders (EMROs)

More details on when and how EMROs can be used.

## **Key points:**

- EMROs can ban alcohol sales between **midnight and 6am** in problem areas.
- They are meant to address recurring, serious late-night issues.
- They override all authorisations except New Year's Eve.

#### What's different?

Old guidance mentioned EMROs only briefly.

The new version gives step-by-step clarity.



## 5. Updated Advice on Applications & Electronic Submissions

Clearer rules for online applications, especially through GOV.UK.

#### Important updates:

- Electronic applications count as "given" on the day the council receives the GOV.UK notification.
- Councils must acknowledge applications quickly and follow strict timelines.
- Applicants no longer need to send copies to responsible authorities when applying online.

#### What's different?

Older guidance barely covered digital submission.

2025 version reflects modern online systems.

# 6. Personal Licence Clarifications

Useful for operators employing personal licence holders.

# Highlights:

- Personal licences remain valid indefinitely and do not expire.
- Police may object to a DPS application only in exceptional circumstances linked to crime prevention.
- Licensing authorities can request more information on management arrangements for community premises.

#### What's different?

Earlier guidance had outdated references to renewal and made DPS objections seem more common.

# 7. Stronger Emphasis on Licensing Objectives

Reinforcement that the four objectives remain paramount:

- Crime & disorder
- Public safety
- Public nuisance
- Protection of children from harm

Operators must show how their venue actively supports these objectives.



#### What's different?

Earlier versions were less explicit.

The new version expects more proactive risk management from venues.

# 8. Counter-terrorism & Safety (Annex)

There is a new emphasis on security for events and venues.

Licensing authorities may look closely at safety plans for large events.

## What's different?

This reflects current national safety concerns and was not emphasised in older versions.
